MEDICARE SURETY BOND UPDATE

On March 17, 2009 the Centers for Medicare and Medicaid Services (CMS) held a conference call with over 700 participants to discuss the Surety Bond regulation released on January 2, 2009. The call confirmed that the regulation is moving forward as stated. Businesses offering Durable Medical Equipment and Prosthetics, Orthotics and Supplies (DMEPOS) must post a minimum \$50,000 surety bond for each National Provider Identifier (NPI) number that they have. The dates have remained unchanged:

- May 4, 2009 – Anyone applying for a new NPI number after this date must have the bond in place.
- October 2, 2009 – All businesses offering DMEPOS must have the bond.

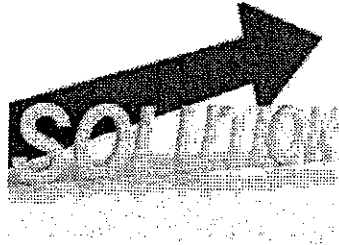
